Sub: Notice of IMS Annual General Meeting to be held online on 23 May, 2025.

In accordance with Clause 3.3 of IMS Constitution, notice is hereby given for the 2025 Annual General Meeting (AGM) of the Society to be held **online on 23rd May, 2025 (Friday) at 1600 Hrs IST**, to consider the agenda provided below. The AGM, expected to be of about 2 hour duration, will be chaired by the President, IMS. All members of the IMS, including Life Members, Annual Members, Student Members as well as Fellows, Honorary Fellows and Patrons are invited to attend the same.

As per Clause 3.3.2 of IMS Constitution, the quorum for AGM shall be 10% of the total membership entitled to vote at meetings of the General Body except for meetings adjourned for want of quorum, for which no quorum is necessary. Keeping this in view, *if there is no quorum at the start of the scheduled AGM, the same will be adjourned by the President and re-convened at 1630 Hrs IST on the same day, i.e., 23rd May, 2025 with no requirement for quorum.*

Chairpersons and Secretaries of Local Chapters of IMS are requested to kindly circulate this notice widely among their respective members and make all efforts to enhance attendance. They are further requested to attend the AGM and briefly present the activities/plans of their chapters in the GB Meeting. In case it is not possible for the Chairpersons and Secretaries of Local Chapters to attend the meeting, a suitable member of the chapter may kindly be deputed for the purpose.
